WE OFFER AFTERSCHOOL AND SUMMER EXTENDED LEARNING PROGRAMS, COMMUNITY SCHOOLS, COLLEGE AND WORK READINESS PROGRAMS, INTERNSHIPS, AND SPECIALIZED GROUPS THAT FOCUS ON ISSUES RANGING FROM SEXUAL HEALTH TO COMMUNITY SERVICE.
